## Saturday, December 6, 7:15/8:00 am Meijer Kids Shopping Day

We expect to take over 40 kids shopping this year – the most ever. So, we need you to volunteer for at least part of your Saturday morning on December 6 to help give visually impaired and disadvantaged kids a happier holiday season! The committee has broken down the volunteering into three parts:

- ♦ Picking up some kids from Saboath Ministries about 7:15 am: (Parents of visually impaired kids will drop them off at Cascade Meijer about 8:00 am.) The committee doesn't need any more volunteers for this.
- Helping kids shop and wrap presents: Many more volunteers are needed here, even though the GVSU Campus Lions Club will be sending their members again this year. (We couldn't do it without them!)
- ◆ Taking all the kids home: More drivers are needed. While the kids from Saboath Ministries live in a fairly concentrated area, visually impaired kids may come from anywhere in the county. It is the committee's goal to have each driver take only two kids to their homes and try to select the kids who live fairly close. For instance, there might be a kid from Rockford and a kid from Cedar Springs.

As a reminder, this annual Meijer Kids Shopping Day will take place at the Cascade Meijer store, just east of I-96 on 28<sup>th</sup> Street SE. After arriving at Meijer, the kids will be given a light breakfast and Grand Rapids Lions, GVSU Campus Club Lions and other volunteers will help the kids shop. Volunteers will also help wrap the kids' gifts before they are given rides home.

The kids will use their \$75 gift cards to shop (\$15 from Meijer; \$60 from the Lions Foundation). "Pass the hat" donations from the Lions luncheons meetings will supplement Foundation funds that will allow more kids to participate.
