## **Tuesday, September 8 616 Development, Monica Steimle**

616 Development says its mission is simple: to build urban community by transforming underutilized spaces into places

where people can live, work and play. This transformation typically, but not always, combines mixeduse development for retail, office and residential uses – what 616 calls "24 hour buildings." 616 Development also has a property development component (616 Lofts) and works to construct projects and then gather feedback from those served to improve future development and operations.



616 has redeveloped a number of properties in or near downtown Grand Rapids, including "the Rood Building" at 139 Pearl Street, 206 Grandville Avenue, 1 Ionia & 7 Ionia (Heartside Entertainment District), the Kendall Building at 616 Monroe Center, the vacant Bethlehem Lutheran Church in Heritage Hill and the new construction on Michigan Street at Eastern Avenue.

Derek Coppess founded 616 Development in 2007 when he realized that urban living offered the opportunity to get to know neighbors. He indicates he wants to foster a sense of place to meet a growing demand for vibrant urban spaces. Mr. Coppess grew up in Lake Odessa, southeast of Grand Rapids, left the area to attend college and returned to West Michigan in 2003.

Monica Steimle is 616's Director of Development. She primarily works on the startup of development projects. This includes, but is not limited to, reviewing neighborhoods and project sites, site acquisition, and working with the neighbors and communities in which 616 invests. Ms. Steimle works on how 616 can improve

the communities it serves and the Grand Rapids community at large. She was raised in Holland, attended Grand Valley State University and had an early career in hotel management. She has 10 years of experience in real estate in downtown Grand Rapids. She lives with her three children in the Belknap Neighborhood.

## **Tuesday, September 15 The Prodigal Government, Peter Letzmann**

What should be done with local governments and school districts that are nearly bankrupt? How did they get that way?

Peter Letzmann has a vast array of knowledge and experience to offer to these and similar questions. He helps small governments, not for profit groups and businesses improve the performance of their organizations. He is an attorney, a court-certified mediator, an educator, consultant, public speaker and author. His interests include the integrity and effectiveness of local governments, mediation, civil rights and employment & domestic issues.

He was the City Attorney of Troy, Michigan for seventeen years. In Troy, he was responsible for all of the city's legal matters, including advising city officials, defending the city against claims and law suits, land use, eminent domain, telecommunications, ordinance prosecutions, personnel and labor, law enforcement, contracts, ordinances and documents. He also had been a Deputy City Attorney for the City of Pontiac and an Assistant Corporation Counsel for the City of Detroit.

Mr. Letzmann graduated from the University of Detroit Law School in 1972. He received his Bachelor of Arts Degree from Wayne State University and has attended the FBI's Police Legal Advisors Academy and other continuing education courses for municipal attorneys. He has made hundreds of presentations regarding legal issues and leadership aspects of government and taught in school at Oakland University and has been an instructor at MSU, EMU, Oakland Community College, Kellogg Community College, Washtenaw Community College and others. He also was an adjunct professor at Grand Valley State and Ferris State Universities. In addition, he has provided training to cities, counties and State departments. He lives in Kentwood.
